This training program provides the necessary knowledge and skills to staff members participating in safety committees as part of the Internal Protection and Prevention Services ( $E\Sigma Y\Pi\Pi$ ), enabling them to carry out their duties actively and effectively and contribute to cultivating a safety culture within their organization.

Additionally, it ensures the company's compliance with the legal framework of the Republic of Cyprus regarding workplace safety and health, as it is a legal requirement (Regulation  $K\Delta\Pi$  158/2021) for the employer to appoint  $E\Sigma Y\Pi\Pi$  and provide appropriate and sufficient training to employees who carry out  $E\Sigma Y\Pi\Pi$  duties.
